## Notice Inviting Tender

Sealed Tenders in the prescribed form are invited by Hyderabad Metro Rail Ltd. from reputed contractors/agencies experienced in plantation of trees who are registered with any Government Department/GHMC, for fixing eligible contractor for taking up plantation of trees with the following conditions.

### (i) **About the project**

The Hyderabad Metro Rail project is taken up in 3 high density Corridors of Hyderabad city to a total length of 72 kms, with 66 stations and 3 Depots at a cost of Rs.14,132 crore. Due provision is made for Metro Rail interchange between corridors, and integration with MMTS, Rail terminals and Bus stations. All necessary steps are taken to make it safe, reliable, efficient, economical and world class public transportation system.

The Hyderabad Metro Rail Project is an eco-friendly Project. The Project enables for mass transportation of commuters as well as reduces air pollution and sound pollution considerably. The commuters are motivated to minimise or avoid usage of motor bikes, autos, taxis, cars and buses. The Hyderabad Metro Rail Department encourages for development of greenery along the Metro Rail corridors, along the cross roads, islands connecting the Metro Rail corridors.

During execution of the Project, it is proposed to take up massive tree plantation along the three Metro Rail corridors, around catchment area of the Metro stations and in other specified places.

## (ii) Scope of Work

- The plants shall be collected from HMDA nurseries, transported to the specified places and planted as per the specification and instructions of departmental officers.
- Work shall be executed as per specifications within the specified time and the rates shall be quoted accordingly considering all the contingencies.
- The work will be allotted to the 1<sup>st</sup> lowest eligible tenderer.

## (iii) Procedure of allotment of work

- The work will be allotted to 1<sup>st</sup> lowest eligible tenderer and the agency shall conclude into agreement by remitting 1.50% EMD by DD in favour of Managing Director, HMR.

## (iv) Eligibility Criteria

The agency shall have experience in plantation of trees and such experience shall be supported by authenticated certificates issued by competent authorities.

## (v) Earnest Money Deposit:

The tender quoting Agency should deposit 1% EMD in the form of a demand draft drawn in favour of the Managing Director, Hyderabad Metro Rail Ltd. The EMD of 1<sup>st</sup> lowest tenderer will be retained up to the completion of the contract period. EMD of 2<sup>nd</sup> lowest tenderer will be retained up to the date of entering into agreement of 1<sup>st</sup> lowest tenderer and released after wards. The EMD of remaining tenderers will be returned after selection of 1<sup>st</sup> lowest tender. The Agency should produce copies of registration with any Government Dept. /GHMC, VAT, Income Tax (PAN) registration etc as applicable.

**(vi) Terms & Conditions:**

1. The tender purchased is not transferable and the Agency purchased shall submit it without fail.
2. Any alterations made in the tender by the Agency in the conditions of contract, specifications, mentioned will be rejected.
3. Sub-letting of works by Agency is not permitted.
4. The sealed tender in the prescribed form shall reach the office of the Hyderabad Metro Rail Limited (HMR), Metro Rail Bhavan, Saifabad, Hyderabad-04 on 18.07.2013 up to 3.00pm and the same will be opened in the presence of the agencies or their representatives who wish to participate at 4.00pm on the same day.
5. Due to any reason if the office happens to remain closed on due date, the quotations will be received upto 3.00pm on the next working day and opened on the same day at 4.00pm.
6. The rates quoted shall be inclusive of all taxes except VAT duly indicating the % of Excess/Less.
7. The Managing Director, HMR reserves the right to cancel any or all the quotations received without assigning any reasons.
8. Agency shall quote the rates in the enclosed 'Form of schedule only.
9. The entire tree plantation work shall be completed within one (1) month. The defect liability period shall be for 12 months from the date of completion of the work. If any defect is noticed within that period the agency has to rectify or replace the same to the satisfaction of the officer incharge of the work.
10. The NIT along with Form of schedule will be available at the reception counter of HMR from 17<sup>th</sup> July 2013 upto 5.00 pm on payment of Rs.1,000/- towards the cost of tender schedule in the form of Demand Draft drawn in favour of Managing Director, Hyderabad Metro Rail Limited and EMD and VAT as mentioned above shall be enclosed along with application.

**(vii) Payment Schedule:**

1. 40% of the contract value will be paid after One month of the completion of Planting in all respects.
2. 20% of the contract value will be paid in the month of Dec. 2013 on completion of scheduled works as per Agreement with in the stipulated time.
3. 20% of the contract value will be paid in the month of March, 2014 on completion of scheduled works as per Agreement with in the stipulated time.
4. 20% of the contract value will be paid in the month of July, 2014 on completion of scheduled works as per Agreement with in the stipulated time.

**(viii) Penalty clause:**

The allotted work shall be completed in stipulated time from the date of work order / failing which a fine of Rs.1000/- per day for delay will be levied until the work is completed.
