Selection of Licencee for Operation & Maintenance of Metro Stations streetscape in serviceable areas (Sidewalks, Intermediate Footpaths, Plazas, Landscaping etc., developed by the Authority) and Construction, Operation & Maintenance of Kiosks etc., (in earmarked locations) on DBFOT basis in PPP mode including Security and Housekeeping at road level below Hyderabad Metro Rail Stations

Hyderabad Metro Rail Limited (HMRL) having its Principal office at Metro Rail Bhavan, Begumpet, Hyderabad - 500003 is engaged in the development of Mass Rapid Transit System in the city of Hyderabad. The Metro network covers a total distance of about 72 km across three corridors in Phase-I. L&T Metro Rail (Hyderabad) Limited, a special purpose vehicle of Larsen & Toubro Limited is the Concessionaire for the Hyderabad Metro Rail project. A part of Metro Corridor i.e., Miyapur to Ameerpet and Ameerpet to Nagole is opened for Commercial Operation covering 24 Metro Stations in a length of about 30 km.

In order to recover the capital expenditure, save on recurring expenditure and to maintain the upkeep of the developed Metro Rail Station precincts, HMRL intends to select a Licencee for O&M of Metro Rail Stations streetscape in serviceable areas for generating revenues through rentals etc., a document inviting Request for Proposal (RfP) for Selection of Licencee for Operation & Maintenance of Metro Stations streetscaping in serviceable area (Sidewalks, Intermediate Footpaths, Plazas, Landscaping etc., developed by the Authority) and Construction, Operation & Maintenance of Bus Shelters and Kiosks (in earmarked locations) on Design, Built, Finance, Operate & Transfer (DBFOT) basis in Public Private Partnership (PPP) mode including Security, Housekeeping etc., at road level below Hyderabad Metro Rail Stations from prospective bidders.
