Interested individuals/Agencies are invited to participate in **OPEN CUM SEALED TENDER AUCTION** of salvage materials of dismantled Foot Over Bridges such as structural steel members consisting of 'C' sections, angle sections, hollow sections including flats, gusset plates and MS sheeting stacked at MRO premises Secunderabad.

Schedule of Auction Process:

1. Last date of receipt of application separately for each LOT along with DD for Rs.2500/- towards application fee & DD for Rs.1,00,000/- towards EMD for lot 1 and DD for Rs.2,30,000 towards EMD for lot-2 drawn in favour of Managing Director, Hyderabad Metro Rail Ltd. Is **20.09.2013 upto 5.00PM.**
2. Last date for issue of tender documents for the two LOTs is **21.09.2013 upto 5.00PM.**
3. The applicant shall furnish copy of proof of photo identity card along with his application (voter card, Aadhar card, pan card and driving license and Passport size photograph.)
4. Sealed tender shall be submitted at HMR Reception separately for each LOT by **23.09.2013 upto 5.00 PM** and the applicants who fail to submit the sealed tender will not be allowed to participate in the open auctions on **24.09.2013.**
5. Open auction will be conducted at MRO premises, Secunderabad on **24.09.2013 at 3.00 PM** for LOT 1& LOT 2 separately with minimum upset values of Rs.10,00,000/- (Rupees ten lakh only) & Rs.23,00,000/-(twenty three lakh only) respectively one after another.
6. Highest bidder in the open auction or the sealed tenders for each LOT will be the successful bidder. If the 1st highest bidder fails to pay the bid amount the 2nd highest bidder will be considered and if even the 2nd highest bidder fails to pay the bid amount the 3rd highest bidder will be considered.
7. All sealed tender bids/auction bids below upset value of Rs.10,00,000/- (Rupees ten lakh only) & Rs.23,00,000/-(twenty three lakh only) for **LOT-1 & LOT-2** respectively will not be considered in any case.


Terms & Conditions:

1. Applications for each LOT without the demand draft of Rs.1,00,000/- for LOT-1 and Rs.2,30,000 for LOT-2 towards EMD will be summarily rejected.
2. Due to any reason if the office happens to remain closed on the last date of receipt of tender, tenders will be received up to 4.00PM on the next day.

3. The Managing Director, HMR reserves the right to reject any or all the tenders without assigning any reason.
4. Any further details can be had from the Office of the Executive Engineer-II, Corridor-III, Metro Rail Bhavan, Saifabad, Hyderabad on any working day during the office hours.

Special Conditions:

1. List of materials kept separately for LOT 1 & LOT 2, the correctness of which is to be verified at site and satisfied by the applicants.
2. The condition of the materials in 'as it is where it is' condition should be satisfied by the applicant before participating in the auction.
3. No disputes will be entertained regarding the quantity and quality of salvage material.
4. Applicants shall give their offer in sealed Tender cover one day before participating in open auction at the office of HMR.
5. Applicants will not be eligible to participate in open auction without furnishing their Tender in sealed cover before 5.00PM on 23.09.2013.
6. Only the authorized applicant (one person per application) will be allowed to enter into the auction premises.
7. Highest bidder in the open auction or the sealed tenders will be the successful bidder for each LOT.
8. The successful bidder of each LOT shall deposit the bid amount within three days in the form of DD drawn in favour of Managing Director, Hyderabad Metro Rail Ltd.
9. If the successful bidder fails to deposit the bid amount before the stipulated time as per condition (8), the earnest money of Rs.1,00,000/- or Rs.2,30,000/- will be forfeited .
10. If the 1st highest bidder fails to pay the bid amount the 2nd highest bidder will be considered duly forfeiting the EMD of 1st bidder and if even the 2nd highest bidder fails to pay the bid amount in given time, the 3rd highest bidder will be considered duly forfeiting the EMD of 2nd bidder. If the 3rd highest bidder also fails to pay the bid amount in the given time the auction will be recalled duly forfeiting the EMD of 3rd bidder.
11. The successful bidder will be allowed to lift the auctioned salvage material with written permission of HMR only after receipt of DD for total auction amount.
12. The earnest money of Rs.1,00,000/- or Rs.2,30,000/- of all the unsuccessful applicants will be returned within three days from the date of open auction.
13. The sealed tender shall be submitted in the Proforma enclosed only **(FORM OF BID)**.
