1. Bids are invited for the above mentioned work from the Contractors / Contracting firms registered with Government of Telangana / AP on L.S contract basis. The terms and conditions can be downloaded from e-procurement website i.e. [www.eprocurement.gov.in](http://www.eprocurement.gov.in).
  2. Approximate Estimate Contract value of work: **Rs. 8,20,56,555/-** (Rupees Eight crore twenty lakh fifty six thousand five hundred and fifty five only)
  3. E.M.D. to be paid by way of unconditional and irrevocable Bank Guarantee issued by any Nationalised /Scheduled Commercial Bank in the standard format as shown in the Tender Schedule in favour of **Managing Director, Hyderabad Metro Rail Ltd** or Crossed Demand Draft for **Rs. 8,20,600/-** (i.e. 1% of ECV) drawn in favour of **Managing Director, Hyderabad Metro Rail Ltd** along with bids, to be valid for six months from date of NIT and the balance EMD @1.5% (i.e. @2.5% of TCV/ECV whichever is higher minus EMD furnished with tender) to be furnished by Contractor at the time of concluding the agreement. The HMR shall carry out the technical bid evaluation solely based on the enclosed certificates/documents, DD/BG towards EMD and open price bids of the responsive Contractors. The HMR will notify the Successful Contractor for submission of original hard copies of all enclosed documents, prior to entering into agreement duly specifying the stipulated time and the Contractor shall submit the documents in time.
  4. The HMR will ensure the genuineness of the DD/BG towards EMD and all other certificates / documents enclosed by the Contractor in support of qualification criteria before concluding agreement.
  5. **Period of completion of work (12) Months.**

12. **Qualification Requirements:** To qualify in technical each Contractor should fulfill the following criteria;
- a) Assessed available Bid capacity as per formula (2AN-B) should be greater than the Estimated Contract Value as specified in the Tender Document
  - b) The details and certificates are to be furnished as per the proforma available in the tender schedules.
  - c)
    - I. The Contractor should have **satisfactorily completed similar works particularly a Single work** of value not less than **Rs. 410.28 lakh** as a Prime Contractor in the same name and style in any one year during the financial years 2009-10 to 2013-14 **updated to 2014-2015** price level. Sub Contractor's / GPA holder's experience shall not be taken into account.
    - II. The Contractor should have satisfactorily Constructed / Completed building of not less than **G+3 Floors** during the last five financial years i.e from 2009-10 to 2013-14.
    - III. The Contractor or his identified Sub-contractor should possess required valid registration under appropriate Class in PH Engineering for executing Water supply & Sanitary Engg Works and should have executed similar **Water supply & Sanitary** works totaling to **Rs. 5.26 Lakh** in any one financial year during last five financial years i.e., from 2009-10 to 2013-14 updated 2014-2015 price level.
    - IV. The Contractor or his identified Sub-contractor should possess required valid registration not below Class I **Electrical**, certificate and license for executing electrical Engg Works and the Contractor should have executed Similar electrical works totaling to **Rs. 34.04 Lakh** in any one financial year during last five financial years i.e., from 2009-10 to 2013-14 updated 2014-15 price level.
    - V. The Contractor should have executed the minimum quantities of items of work as given below in any one year during the financial years 2009-10 to 2013-14. The Contractor should enclose certificate issued by the Engineer-in-Charge of the State / Central Government HMR undertakings not below the rank of Executive Engineer, or equivalent and countersigned by the officer of the rank not less than rank of S.E or equivalent.

The Contractor should submit the particulars invariably in the format specified in the tender schedule along with necessary certificates, failing which his tender shall be treated as incomplete and summarily rejected.

13. The Contractor should further demonstrate:
- I) Availability (either owned or leased) of the following key and critical equipment.

- II) The Contractor should possess Steel Centering and Steel Scaffolding pipes, Wallers, Foot Plates, Brackets etc of not less than 2000 Sqm.
- III) Availability of key technical personal with adequate experience One Graduate Engineer and two Diploma holders.
- IV) Liquid assets/credit Facilities / Solvency certificate from Nationalized / Schedule Banks of value not less than **Rs 205.14 lakh**.
- V) E.M.D. for Rs. **8,20,600/-** to be paid in the shape of Demand Draft/ bank Guarantee in favour of Managing Director, Hyderabad Metro Rail obtained from Nationalised Bank / Scheduled Commercial Bank, at 1% of the estimated value of work to be valid for 6 months from the date of NIT.
14. The Contractor shall be black listed and the EMD forfeited if he is found to have misled or furnished false information in the forms/statements/certificates submitted in proof of qualification requirements or record of performance such as abandoning of work not properly completed in earlier contracts, inordinate delays in completion of the works, litigation history and / or financial failures and /or participated in the previous tendering for the works and had quoted unreasonable high bid prices.
15. Even while execution of the work, if found that the Contractor had produced false/fake certificates of experience he will be black listed and the contract will be terminated.
16. The successful bidder shall pay a non refundable Tender fee of Rs. **20,000/-** in the shape of DD drawn in favor of **Managing Director, HMR**.
17. The successful bidder shall pay an amount of 0.04% of ECV towards corpus fund for e-procurement. DD drawn in favor of **Managing Director, APTS**.
