The work involves cutting that 5 miscellaneous trees of Parkia biglandulosa(1no.) and peltophorum (5 nos.) existing on the right side of road Andhra Bank to Osmania Meidical college falling in the alignment of Corridor-II to ground level including cutting of trunks, branches etc., and carting away all the useful material with all lifts as per Technical Specification Clause 201 MORD / MORTH. The work should be completed within One month from the date of award.

Terms and conditions:

1. The intending Bidders who are interested to take part in the Bidding in open Auction shall pay Earnest Money of Rs 3000/- in the shape of Demand draft/Bankers Cheque drawn in favour of "Managing Director, Hyderabad Metro Rail Ltd., " along with proof of identity of applicant.

2. The balance sale amount and Income tax @ 2.5% shall be paid within Seven days from the date of confirmation of the sale failing which the EMD of Rs.3000/- paid will be forfeited.

Successful bidder shall cut and cart away all useful part of trees felled on the same night itself, **without hindrance to the traffic and during the night times within One month** from the issue of work order. Any slackness in carting of felled tree parts will be viewed seriously and HMR will have right to take any appropriate action including that of cancelling the work order and taking penal action. The bidder shall make their arrangement for obtaining LC are any other co-ordination required from TSSPDCL required for any for such tree felling.
4. The successful bidder shall take care of the standing and felled trees from the date of confirmation.
5. HYDERABAD METRO RAIL LIMITED will not be responsible for any loss or damage of the standing/felled trees due to rain, fire, theft etc and no extension of time will be granted.
6. The successful bidder is solely responsible for the loss of life and property if any occurred during the process of felling of trees.
7. Due to any reason if the office happens to be remain closed on the date of auction, auction will be conducted at 11.30 AM on the next day
8. The Managing Director, HMR reserves the right to reject any or all the tenders without assigning any reason.
