Registered Electrical class -I contractors who have executed Electrification works (7.50 lakhs)of estimated cost,atleast in any one year during the last five years.6. Contractor should enclose experience certificate of similar works of Government Department duly attested of concerned department officer not below rank of the EE.

- 1 The cost of Tender Schedule is not refundable and should be remitted by Demand Draft drawn on any Nationlized Bank in favour of Managing Director, HMR.
- 2 The contractor should enclose their proof of registration of Class-I in State Govt.and executed single Electrification work worth of (7.5 lakhs)of estimated cost atleast in any one year during the last five years.
- 3 EMD @1% should be remitted along with tender application in the shape of Demand draft in favour of Managing Director, HMR
- 4 The Tender Schedules are not transferable
- 5 Experience details of last five years in similar works in state or central Govt. Departments Electrification work worth 7.5 lakhs)of estimated cost executed should be enclosed.
- 6 Tender received without valid certificates will be summarily rejected.
- 7 Latest income tax/commercials tax clearance certificate, VAT,PAN and Registration copy etc.,
- 8 Availability of key personnel and critical equipment
